

1. SkyWest Airlines provides scheduled passenger air service at Oxnard, California. SkyWest Airlines flights are operated as United Express pursuant to a code-sharing agreement with United Airlines.
2. At the time of this filing notice, SkyWest Airlines serves Oxnard with three daily round trip flights to/from Los Angeles, CA. All service is provided with the 30-seat Embraer EMB-120 Brasilia aircraft.
3. Oxnard has Essential Air Service Community designation, but is within 100 miles of Burbank, CA, a medium hub as determined by the DOT, and therefore is not eligible for subsidized air service.
4. The effective date of this notice is February 19, 2010 and the last day of service is scheduled for June 8, 2010.
